COUNCIL MEETING - REVISED Thursday, May 24, 2018

A regular public meeting of the New Jersey Council on Developmental Disabilities was held on Thursday May 24, 2018 at the Hilton Garden Inn, Hamilton, New Jersey. The meeting was called to order at 10:55 am by Paul Blaustein, Chair Person, who presided and read the Open Public Meeting Act and Council Vision. The meeting notice was published in the *Newark Star Ledger* and the *Trenton Times*.

Approval of Minutes / Announcements

Approval of Minutes:

The minutes from the January 25, 2018 meeting were distributed.

Action:

Motion made by Bill Testa to approve the minutes, Seconded by Kevin Nunez The minutes were approved and will be added to the website.

Announcement:

- ❖ Paul requested that members to reply to Council Meeting email announcements with their attendance.
- Tom Baffuto, Executive Director of Arc NJ, was thanked for his leadership of the DSP Coalition.
- Council Consumer Caucus takes place the night before Council Meetings and are open to all Council members. This meeting reviews the Council Meeting agenda and encourages self-advocates to express their needs and request support from the Council.

Public Comment

- ❖ Dr. Richard Harding was present and asked the Council to fund a pilot program in Cape May County for children's transitioning program for ages 18 − 21. The program would provide on life skills training and inform families of their rights. Dr. Harding was introduced to Frank Latham, Council Staff and was directed to the Mini Grant program.
- ❖ Myrta Rosa was present and commented about the payment card being developed for Access Link riders. The card, currently in development, would allow passengers to pay fares without the need to carry cash.

- ❖ Joan Migton was present and expressed her concern that implementation of HIPPA requirements prevents families from obtaining information regarding assaults upon their children by other individuals with I/DD. She wants families to have access to police reports, agency UIRs and DHS investigations. The Council Chair will pursue this issue with and on behalf of Joan Migton.
- ❖ Rebekah Novemsky was present and expressed her concern that the new DCF leadership may not be knowledgeable about the need for support services for children with I/DD and their families. An invitation to future Council meetings will be sent to DCF.

Action:

Motion by Bill Testa to make DCF a mandated member of the Council.

Motion amended by Bill Testa to consider changing the By-Laws to request DCF to attend meetings as a voting member. Seconded by Kevin Nunez and open for discussion.

Motion passed unanimously.

This information will be sent to the Children's Sub-committee and discussed at the next Executive Committee Meeting.
